## Seven Steps to Certification

## Call CCOF for the Application Package.

Call the Statewide Office at 1-888-423-2263 and ask for an application package (\$25), or email us at ccof@ccof.org and we will call you. The initial cost to become CCOF certified includes a \$250 application fee and the cost of an inspection.

Register Your Operation with the County.

If you intend to sell any product as "Organic," you must comply with CCOF's standards under the National Organic Program and the California Organic Program. Information on organic registration (including procedure and fees) is available from your County Agricultural Commissioner's office or from California Department of Food and Agriculture (CDFA) Organic Program at (916) 654-0919.

Read the CCOF Handbook.

The Handbook contains the organic standards that CCOF members need to comply with and you will find detailed information on how the certification process works. Start by reading the *Procedures and Policies*, Organic Practices, and List of Materials to get acquainted with our certification program. If you are a grower, please read our Crop Standards in addition to our Basic Standards. We also have standards for processors and handlers, retailers, and livestock producers.

## Send in the Application and Fee.

Complete the General Information part for your operation and provide 3 years of land history verification. Please sign the affidavit and provide us with maps of the parcels intended for organic production.

Inspection Report Review.

Your Chapter Certification
Committee and the CCOF
Statewide Office will review
your inspection report and assign a certification status
to your operation.

## Chapter Assignment and Inspection.

Your application will be reviewed by our Statewide Office and CCOF will assign you to a local chapter. A trained inspector will call you to set up your first inspection.

CCOF encourages participation in CCOF chapters. Chapter meetings provide an excellent opportunity to meet other organic producers in your area and familiarize yourself with the organization. Your Chapter Coordinator will inform you when a meeting is scheduled in your chapter.

Certification Status Notification.

Upon completion of the review process, you will receive a letter from CCOF which confirms your organic certification status. It will also inform you of any requirements for further certification.
